A new date to receive comments on the proposed applications has not yet been scheduled. Notice will be provided when the new meeting is scheduled.

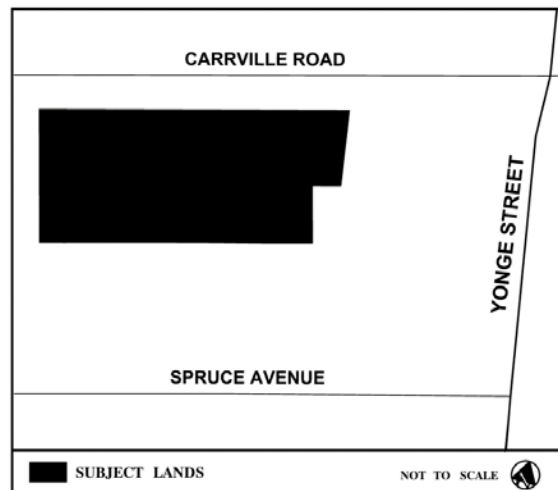

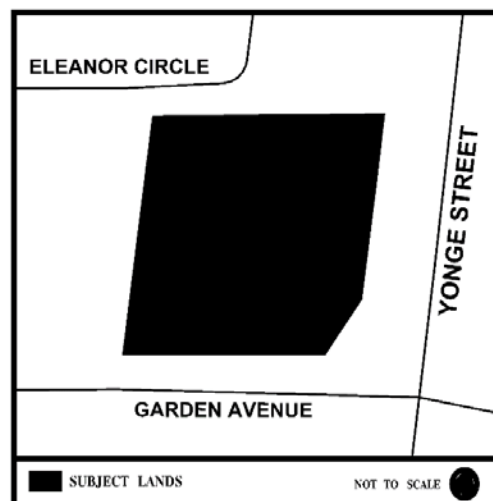

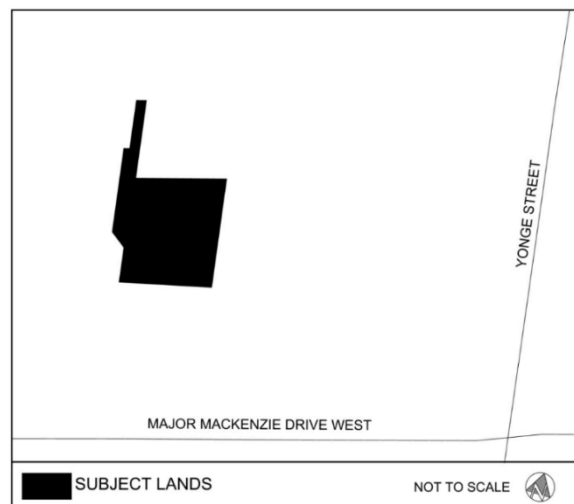
